Nafaa Makadsi ("Noofi") is an amazingly talented young man that has literally traveled miles to break down the barriers of Down Syndrome and express himself through his art.

Noofi was born in Baghdad Iraq. In 2003

when Iraq became unsafe due to war, Noofi and his family fled to Jordan where they lived until they traveled to the United States in 2008. In 2014 Noofi proudly became a US citizen. While in Iraq, little to no supports were provided to individuals with disabilities. Noofi's mother and grandmother worked with him academically and his grandmother taught him art. At the age of three Noofi created his first drawing, a portrait of his

grandmother and he hasn't stopped drawing since. Today Noofi draws everyday creating his abstract masterpieces. He will draw on anything when he feels inspired,



from napkins and pizza boxes to mixed media paper. While Noofi, currently does not sell his artwork, his primary goal is to eventually make a living with his art.



Through his Self-Determination arrangement and the assistance of a fiscal intermediary, Noofi hires his own staff, who assist him in developing his own business ideas and

creating prints of his art that he hopes to one day sell. They also assist him with his computer and English skills and spending time in his community. Noofi enjoys getting out in the community and volunteering at a

variety of places including various retail stores and at his school. Noofi also has a part-time job at Pizza Hut. At Pizza Hut he works independently folding boxes. His work hours vary however currently he is working about 4 hours per week on Wednesdays.



For fun Noofi likes spending

time at the Joe Dumar's Fieldhouse to play basketball; he is a big fan of Michigan State. He also enjoys learning new dance moves and creating with Legos.

Noofi is very close to his family and currently lives with his very supportive parents. He indicates that he is very happy with his living arrangements at this time.

Noofi's Independent Supports Coordinator, Jennifer Kacin, describes Noofi as a "bundle of joy and an inspiration; he is very enthusiastic about life."

#### **OAKLAND COUNTY BUDGET UPDATE**

You may have seen the recent newspaper articles related to the funding situation in Oakland County. In a nutshell, the Oakland County Community Mental Health Authority (OCCMHA) used \$11 million of their reserves to fund our overall mental health service costs for this year, and now those funds are no longer available so effective October 1<sup>st</sup>, there will be an \$11 million reduction in funding available for the Core Provider Agency (CPA) contracts. It is also still unknown if the state will do another negative "rebasing" of funding come October 1<sup>st</sup> (the last round of "rebasing" led to significant funding cuts in Wayne, Macomb, and Oakland Counties). There are still a lot of unknowns for sure and we know how stressful times like this can be.

OCCMHA has announced that they will be meeting with each of the Core Provider Agencies, including CLS/OC during the month of April to begin proactively planning for the October 1 reductions. They have said that they will be evaluating rate variances and inconsistencies in funding while they are implementing the upcoming reductions. We are optimistically hopeful that this could be good news for CLS/OC's service funding as we have worked hard to achieve fair service authorizations and consistency in rate setting across our entire service network. We are appreciative that we will soon know our projected funding for the next fiscal year so that we can begin thoughtfully and carefully planning for any changes that may need to be made.

#### RENTAL ASSISTANCE TO PERSONS WITH DISABILITIES



On March 20, 2015, Michigan Department of Community Mental Health announced through a press release that Michigan has been selected to receive more than \$5.5 million in U.S. Department of Housing and Urban Development (HUD) funding to provide affordable rental housing and supportive services to extremely-low income persons with disabilities. The Section 811 Project Rental Assistance (PRA) grant application process was a collaborative effort between the Michigan State Housing Development Authority (MSHDA) and the Michigan Department of Community Health (MDCH).

The funding will be administered by MSHDA. A workgroup consisting of representatives from MSHDA and MDCH will collaborate to identify, refer and support target populations throughout Michigan.

In the press release, Nick Lyon, director of the MDCH and interim director of the Department of Human Services said. "Promoting community-based services and systems of care for persons with disabilities is essential to ensuring that all of our residents have the support they need to lead healthy, productive lives. This grant is a testament to inter-departmental collaboration, and I look forward to continued partnership with MSHDA as we work to provide stable, inclusive environments for those individuals and families who need it most."

Michigan was one of 25 states selected to receive funding from the Section 811 PRA program. # NEW PROPOSED RULE – STATE VOCATIONAL REHABILATION, SUPPORTED EMPLOYMENT. SUBMINIMUM WAGE

On April 16, 2015, the US Department of Education unveiled a Proposed Rule regarding State Vocational Rehabilitation Services Program; State Supported Employment Services Program; Limitations on Use of Subminimum Wage. The Rule proposes to amend the regulations governing the State Vocational Rehabilitation Services Program and the State Supported Employment Services Program in order to implement changes to the Rehabilitation Act of 1973, as amended by the Workforce Innovation and Opportunity Act (WIOA) enacted on July 22, 2014. The rule also proposes to update, clarify, and improve the current regulations. It also proposes to issue regulations regarding limitations to use the subminimum wages that are added by WIOA.

President Barack Obama signed the Workforce Innovation and Opportunity Act (WIOA) into law after it passed Congress by a wide bipartisan majority. WIOA is designed to help job seekers access employment, education, training, and support services to succeed in the labor market and to match employers with the skilled workers they need to compete in the global economy. This Act makes important changes to disability programs. The Act will increase individuals with disabilities access to

high-quality workforce services to prepare them for competitive integrated employment. It requires better employer engagement and promotes physical and programmatic



accessibility to employment and training services. Youth with disabilities receive extensive preemployment transition services to obtain and retain competitive integrated employment. It will also create an Advisory Committee on strategies to increase competitive integrated employment for individuals with disabilities. WIOA will become effective on July 1, 2015, the first full program a year after its enactment.
